8:00 - 9:00 AM	<p>Session 1: Much ADU About Housing <i>The City of Lexington is expecting over 80,000 additional people in the next 20 years, including nearly 30,000 seniors. Providing housing options for this aging population is becoming increasingly important here, and accessory dwelling units (ADUs) can help provide the flexibility to allow seniors to age-in-place. In this session you will hear how Lexington's Division of Planning worked with the City's Senior Services Commission, AARP, and the University of Kentucky, College of Design on the policy goal of permitting this housing type. This deliberate process that has been going on for over a year has included extensive research on national best practices, a robust public outreach campaign, and numerous presentations to elected and appointed officials, as well as interested civic and neighborhood groups.</i> Presenters: Chris Woodall, AICP, and Chris Taylor, City of Lexington</p>

Aligning Multiple Simultaneous Planning Initiatives <i>The City of Covington has been engaged in three major planning initiatives simultaneously, including a new hybrid zoning code (form-based and Euclidean components), a city-wide economic development strategy, and a master planning effort for the redevelopment of a 23-acre federally owned site along the downtown riverfront. All three projects began in January and each is a priority for City staff and elected officials. Staff has managed three teams of consultants with an eye toward assuring a cohesive community vision and creating the tools required for implementation. This session will help planners understand the need for coordination among partners to achieve cohesion and community consensus. More specifically how community objectives such as wealth creation, job and talent attraction can be impacted by development of market-based planning, land use regulations and design standards.</i> Presenters: Tom West, AICP, Christopher Myers, and Ross Patten, City of Covington</p>

10:30 - 11:30 AM	<p>Session 3: Development Capacity: Statistics and Geography <i>In a profession that is, rightly so, dependent on surveys, public feedback, and other qualitative analysis it is easy to relegate the importance of having quality quantitative data to back up those findings. This session will demonstrate examples of how to identify and plan for future growth through data driven analysis. Session attendees will learn various techniques to identify reputable data sources and how to statistically analyze and calculate population, housing, and household demographic shifts. Additionally, attendees will leave with the knowledge to geographically represent and calculate their own jurisdiction's development capacity using GIS based mapping.</i> Presenters: Megan Bessey, and Jill Conniff, PDS of Kenton County</p>
11:30 - 12:45 PM (Lunch)	<p>Session 4: This Land is Your Land, This Land Is Our Land: The Importance of Connecting People to Open Space While Also Activating Vibrant Urban Spaces <i>Lexington's comprehensive plan, urban service boundary, and the new Placebuilder Tool, now used to evaluate zoning change proposals, all work in concert to build in density within the core and target environmentally sensitive areas, like greenways, for protection and public use. This allows open space and farms outside the urban service area to remain at a lower density while providing for the economy through tourism and agricultural jobs. This bolsters the characteristics of Lexington's landscape that contribute to our sense of place. This session will be a panel discussion about connecting people to the rural landscape that comprises much of the Bluegrass identity while also prioritizing the energizing of urban areas to provide for dense, sustainable, and vibrant mixed use development.</i> Presenters: Ashley C.
